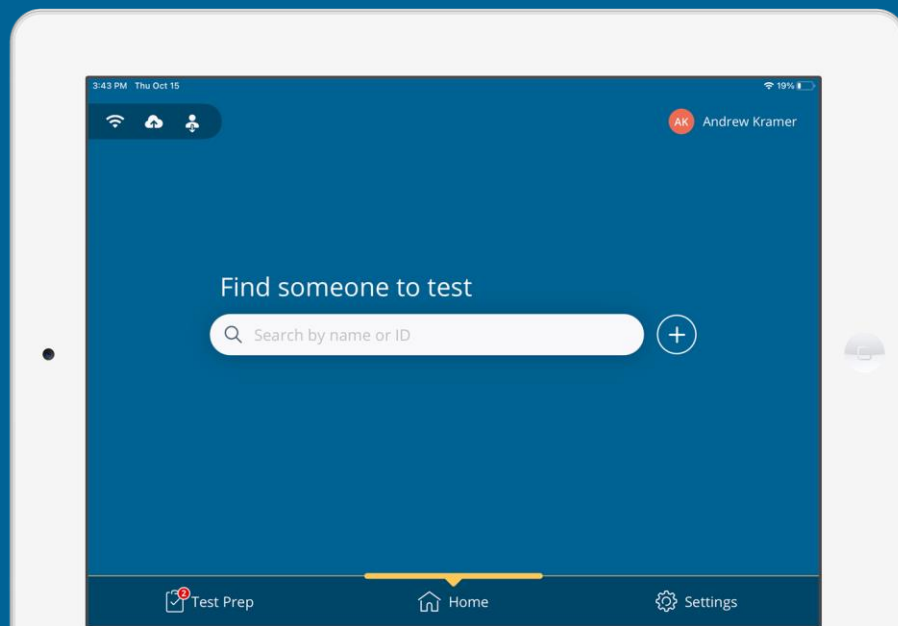

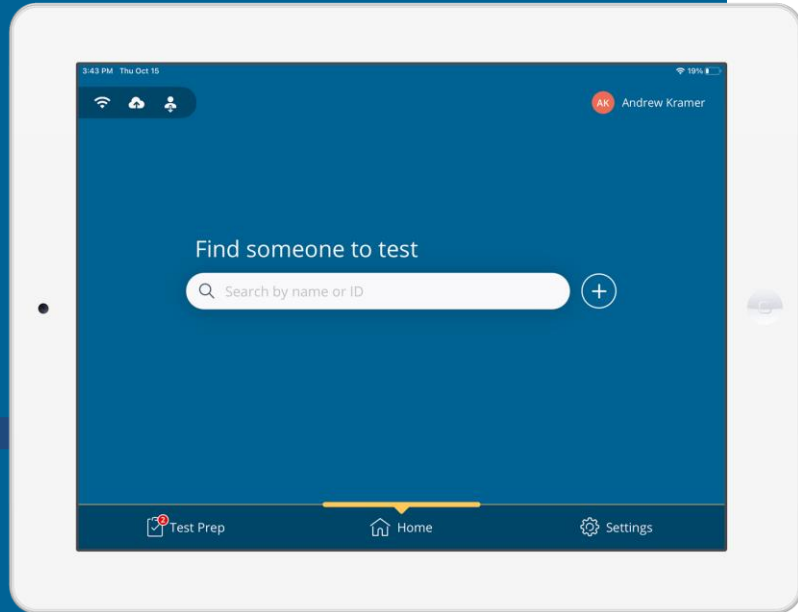

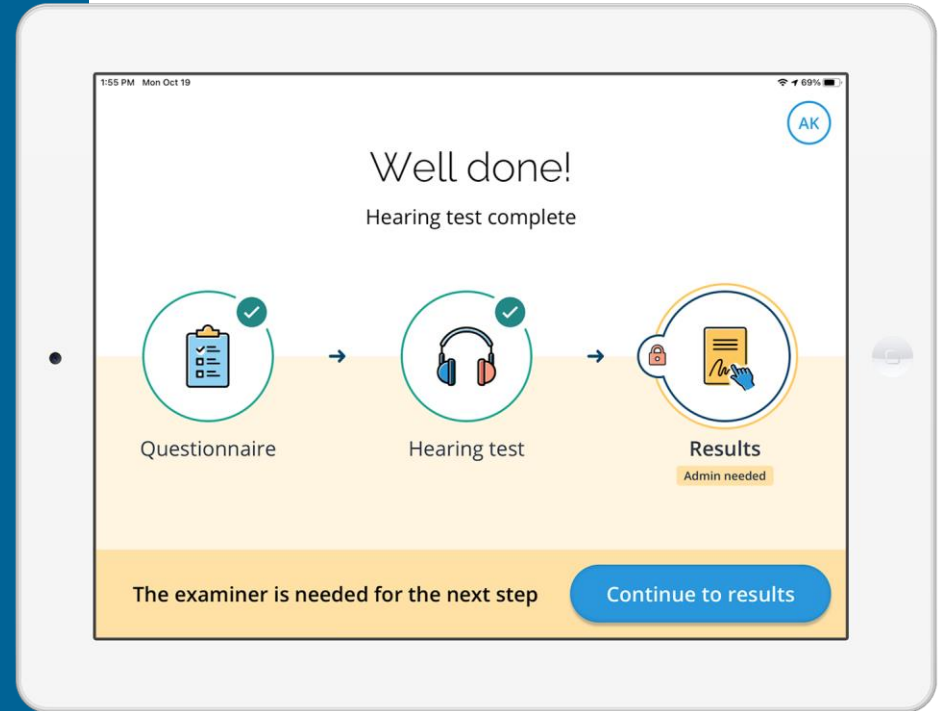

Workflow

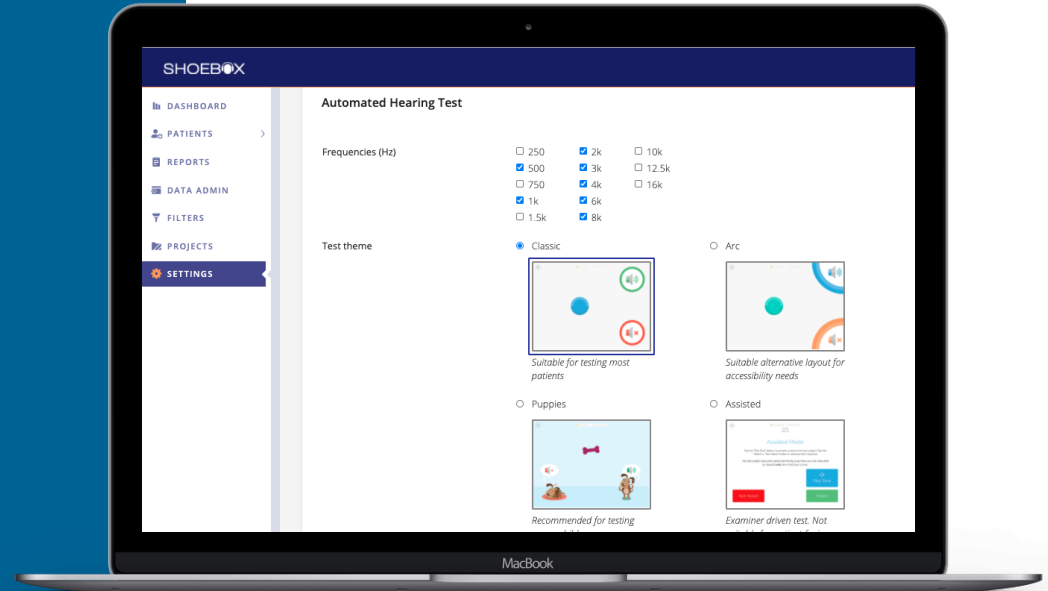
- First workflow based audiometer

Fleet Management

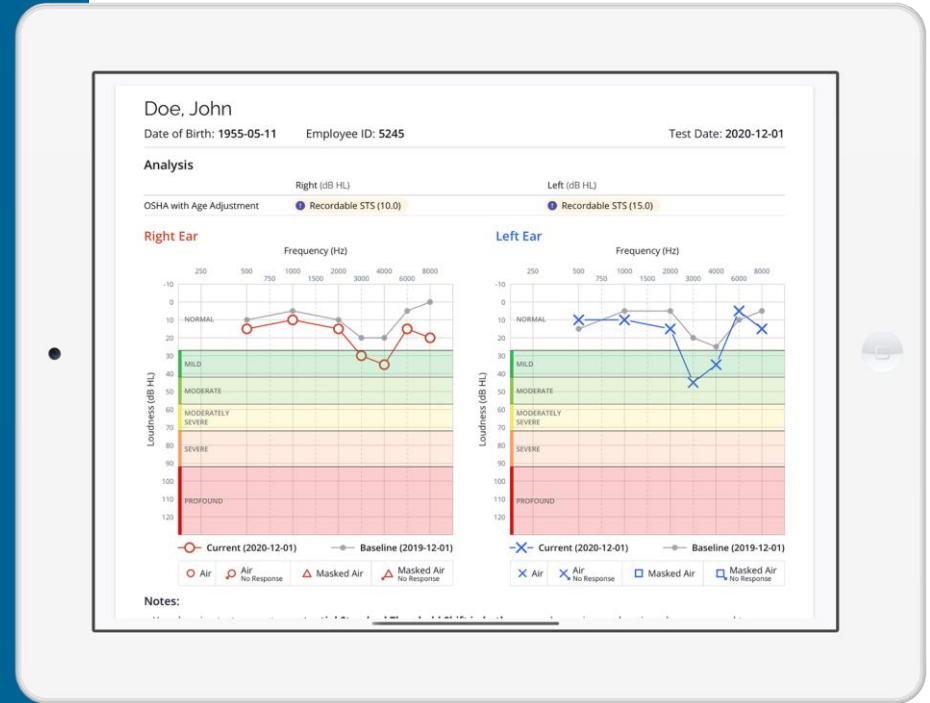
- Test settings are configured in portal and pushed to your device - whether single or a fleet of devices

Offline Shift Analysis

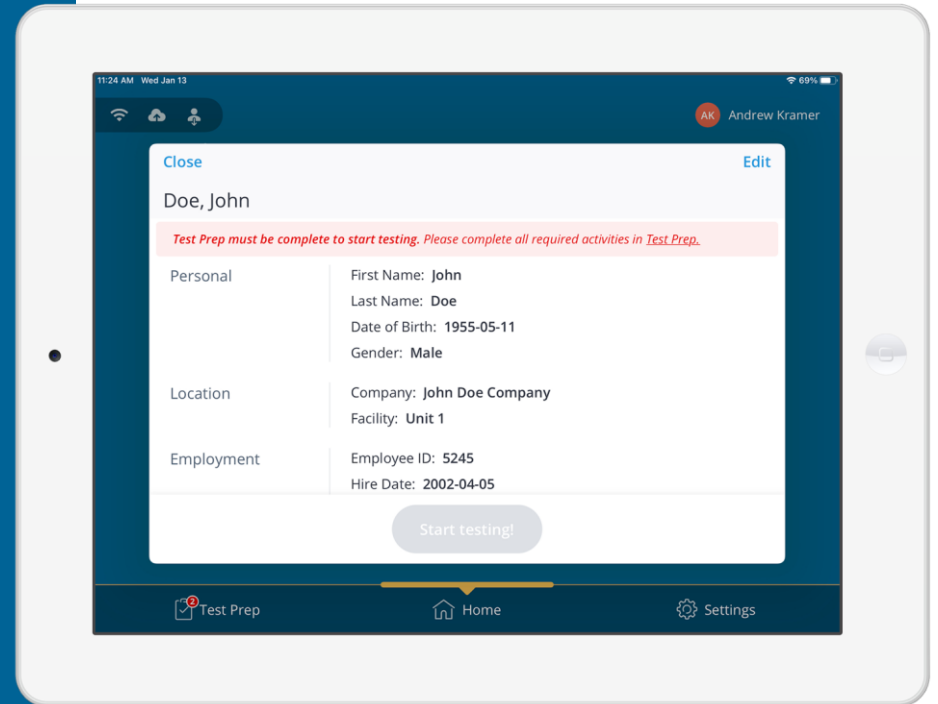
- Determine threshold shifts directly on your device even when offline



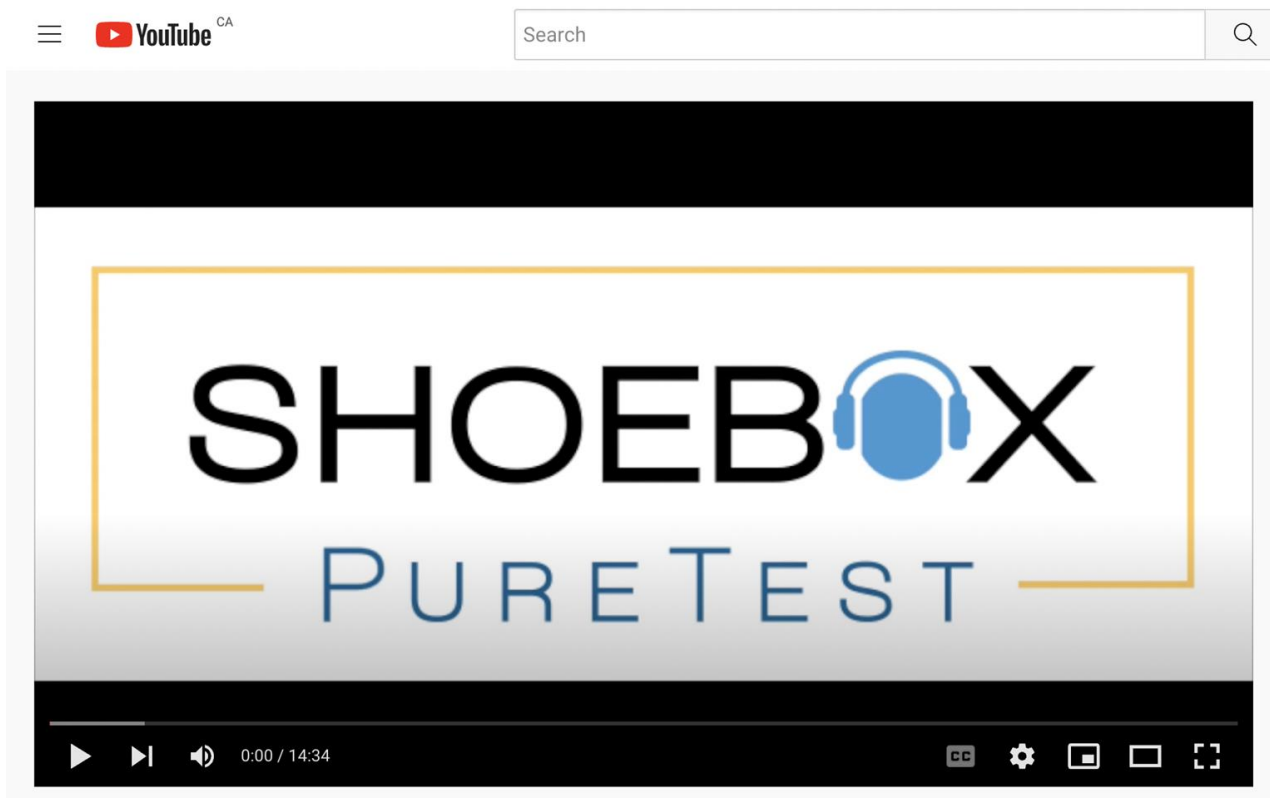
